SECTION 4. FIRST AID MEASURES

SECTION 6. ACCIDENTAL RELEASE MEASURES

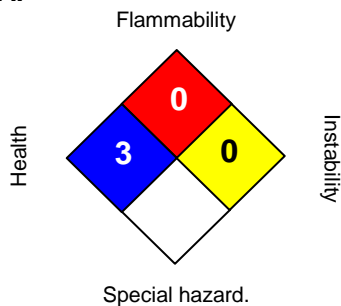
