SECTION 4. FIRST AID MEASURES

SECTION 6. ACCIDENTAL RELEASE MEASURES

Combustible materials exposed to this product should be rinsed immediately with large amounts of water to ensure that all product is removed. 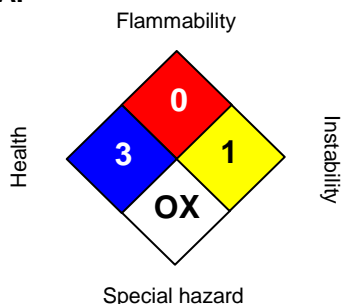
